When you donate to a charity through Gift Aid, the charity can claim an extra 25p for every £1 you give. This additional amount is provided by the government, and it doesn't cost you anything extra. If you are a taxpayer and would like the parish to claim gift aid on your weekly/monthly/annual donations, please contact the parish office for a gift aid declaration form. You can choose to pay by weekly envelope or by standing order or an annual cheque.
